Since May 25th, 2016 the Regulation (EU) 2016/679 on General Data Protection (hereinafter, "GDPR") is in force, and has been fully applicable as of May 25th, 2018. In this case, we will ensure that the entities receiving your data comply with the requirements of the regulations in force and that they have adopted, for this purpose, the appropriate security means.

Finally, your rights as data subjects have been extended to the following ones: right of access, rectification, to restriction of processing, to erasure, to data portability, to object, to revoke your consent, and to object an automated individual decision-making process. Likewise, the data subjects can file a claim before the AEPD whenever they consider that their rights have been violated within the framework of our data processing.
